WHAT IS THE STATUS OF VOTING IN CENTRE COUNTY?

We have some late breaking news on election security that we want to give you that adds to the information we reported in the *Helping Hands* column the Public Policy Committee wrote for the *Centre Daily Times* last week. Please do share these updates!

What is the fastest way to have your vote counted in Centre County? Drop off your vote by mail ballot or mail it early enough to have it arrive before Election Day. How can this

be true when we've heard so much about the vulnerability of mail-in ballots? Because the Centre County Commissioners have stepped up. Also, the Post Office management settled a lawsuit forcing them to restore r operations to their former status.

Here is what our Commissioners did. They assembled over 200 volunteers ready to start processing mail-in ballots the minute the polls open on Election Day. Their efforts, combined with newly purchased machinery, mean mail-in ballot results are expected to be reported by 8:30 pm on Election day. That's faster than any precinct in the county can close their polls, run their tallies, and drive their results to the official counting location.

These results can't be challenged on security grounds because of the Commissioners' steps to protect integrity. As ballots are collected from camera-monitored drop-off boxes around the county, election workers will go in teams made up of registrants from each major political party, escorted by Sheriff's deputies.

If you don't have a mail-in ballot but now think you would like to get one, go to the Bryce Jordan Center on the Penn State campus where the Commissioners set up a satellite Elections Office. You can apply for and receive your ballot on the spot, then vote and turn it in before you leave. The Board of Elections has partnered with Penn State to make the Bryce Jordan Center a satellite elections office and Election Day poll site for the 2020 general election. MAIL-IN VOTING UPDATES

Rumors about voting are confusing people. Most rumors are wrong, but they have caused some who applied for mail-in ballots to change their minds, now wanting to vote in-person. You can do that, but you must do it correctly.

Be sure you take with you every piece of paper that came with your mail-in ballot. The reason is that the people working at your poll will know you applied for the mail-in ballot. If you walk in and ask for an in-person ballot, they will think you are trying to vote twice. That's a felony, so they can't give it to you unless you prove you never used the mail-in ballot. That's why you must take all the paper, so that your mail-in ballot can be invalidated. If you only take some of the paper, you may be given a provisional ballot. Those get sorted out in the end, but it's not a desirable way to vote if you are worried about the count on Election Day.

Did you change your mind about the mail-in vote due to worries about USPS delays? If you mail the ballot back by two weeks before Election Day (or November 2), the mail should be fine. Are you still not convinced you can trust the mail? You can deliver your ballot yourself to a secure drop box. Those boxes are monitored by cameras for security reasons. You will find one at the county offices in the Willowbank Building in Bellefonte, the State College Municipal Building, and other locations.

The locations are listed at an icon on the newly redesigned Centre County Elections Office homepage. You'll find links there for almost everything you might want to know. Go to <u>centrecountyvotes.com</u>. You can apply for a ballot, find out how to return it, track it as you would a package, and even view results at the clearly marked icons.

Is mail-in voting valid? Yes. Our military has done it since the Civil War. Their ballots always are accepted a few days after Election Day, to allow for the mail. As for verification, when you vote in-person, you sign the book; when you mail-in, you sign the back of the outer envelope (be sure your ballot is sealed in the inner secrecy envelope). In both cases, your signature is compared to the one on record with the Elections Office. Bar coding keeps ballots from being fraudulently duplicated.

Because we no longer have straight ticket voting, please vote individually for each of your preferred candidates.

EDUCATION UPDATES

We keep abreast of educational issues that currently revolve around the pandemic. Cyber charter schools are booming. Local income from tax revenues is down due to COVID and public schools have budget shortfalls.

We encourage everyone to write to Senator Toomey and elaborate on the consequences of inadequate school funding in your district. We have long been concerned about the operations of charter schools and proposed legislation would increase fiscal oversight for charter schools; if House Bill 2833 passes, it would make all charter schools subject to audit by the auditor general.

Schools need advocacy during COVID. The September 15 webinar, "Public School Advocacy in the New Normal of a COVID-19 World", was presented by Sue Spicka of PA Schools Work with representatives from the Lancaster SD and the Public Citizens for Children and Youth. Local income from tax revenues is down due to COVID and taxpayers need more time to pay taxes. Combine this with low interest rates, and public schools have a shortfall between \$850 million and a billion dollars. As a result, many school districts laid off support staff. Charter school enrollments are at an all-time high--only the PA Cyber Charter has an enrollment cap.

Since Pennsylvania has one of the lowest amounts of school funding due to reliance on property taxes, federal aid is needed to meet the school budget gaps. Suggested actions are to write to Senator Toomey and introduce yourself to state lawmakers, via social media or other means, and tell them your story about the need to increase school funding.


MID-STATE LITERACY COUNCIL HOSTS NOVEMBER 12 VIRTUAL SPELLING BEE

FAIR DISTRICTS PA - CENTRE COUNTY REDISTRICTING LEGISLATION

Fair Districts PA has shifted its focus from pursuing a constitutional change to prevent gerrymandering to improving the current redistricting process to make it fairer and less partisan. The Legislative and Congressional Redistricting Act (LACRA), also House Bill 2638, mandates a more transparent process, public engagement, map-drawing criteria, and accountability to the voters. The same bill has been introduced as Senate Bill 1242. Both bills have been set to their respective committees; SB 1242 has already reported

out of committee. The goal of these efforts is to have districts that reflect the will of the voters. For more information, consult fairdistrictspa.com.

You can help. Contact Senator Jake Corman (717-787-1377 or 814-355-0477) and ask him to bring SB 1242 up for a vote soon. Contact your state representative to help push HB 2638 out of committee. If you live in Representative Benninghoff's district, contacting him will be especially helpful because he is majority leader of the Pennsylvania House of Representatives (717-783-1918 or 814-355-1300). Bombard your legislators with email, phone calls, or even better, a personal visit.
