## JUDICIAL GERRYMANDERING AMENDMENT UPDATE

Republican leadership in the Pennsylvania legislature has proposed a constitutional amendment that would create districts for Pennsylvania Supreme Court and intermediate appeals court justices to run in. A great many practical problems exist with regard to how this Amendment would be applied, and no evidence suggests it is necessary.


The latest update is that this bill will not come up for a vote in time to go on your ballot for the spring primary. The reason is lack of Republican votes in the State House. In addition to opposition from organizations like the League of Women Voters, we understand that the Republican business community has weighed in against this bill.

We consider this a temporary victory. The bill is poised to run at any time when public opinion shifts. Having passed in the prior legislative session, this bill is live until the end of 2022.

How do we prevent that? Please note that Letters to the Editor have proven remarkably effective lately in keeping on the pressure for justice and reform. We encourage you to add your voice.

## BILLS ADDRESS LEARNING GAPS AND AN INCREASE IN TRANSPARENCY IN EDUCATION



The pandemic didn't create fiscal problems in education, but it further strained district budgets. The Pennsylvania Association of School Business Officials *2021 School District Budget Report: "The COVID Impact"* looks at state trends in school revenue and instructional aspects of the pandemic. Of the responding districts, 75% reported higher instructional costs, 73% saw higher special education costs, and they still had to make payments to charter schools. Concurrently, cyber school enrollments increased by 20,000 students, translating into a statewide increase of about \$350 million. HB 197 was just introduced to make cyber charter management companies subject to audit by the Auditor General.

The pandemic also gave new meaning to the digital divide. Some school districts reopened online within two weeks, while others needed months to develop virtual education programs. Due to these delays and problems with technology, many students received far less education than others. The state's constitution requires the state to provide "maintenance and support of a thorough and efficient system of public education". In response, state representative Dan Miller (Allegheny Co.) introduced House Bill 86 to create a grant program to ensure that our low-income students have both computer and internet access, and to ensure that the schools are better prepared for future emergencies. Let's hope that HB 86 and 197 are successful.




## APPLICANTS SOUGHT FOR AAUW STATE COLLEGE BRANCH SCHOLARSHIPS

AAUW State College seeks applicants for four undergraduate scholarships to be awarded for the academic year 2021–2022 (Fall 2021 until Summer 2022). An applicant must be a woman who:

- is a Centre County resident, with intent to maintain such residency for the duration of the grant, although she may attend a college or university located outside the county;
- is seeking her first associate or baccalaureate degree on a part- or full-time basis;
- has interrupted her studies for at least two years or delayed higher education for at least two years after graduating from high school, having enrolled in a post-secondary institution;
- has completed at least one quarter of the course work required for the degree (15 credits for an associate degree or 30 credits for a baccalaureate degree);
- demonstrates financial need, academic promise, clarity of educational goals, and community service

References and financial information are required. The awards range from \$3,000 to \$7,000, depending on financial need and the recipient's circumstances. The **Application Deadline is March 1, 2021**. The program is sponsored by AAUW Huntingdon and Juniata College.

### February 18, 7:00 pm - Mireille Rebeiz: *The Humanist Omniscient Narrator*

Mireille Rebeiz, Assistant Professor of French & Francophone and Women's, Gender & Sexuality Studies at Dickinson College, will discuss the role of the omniscient narrator in Andrée Chérid's works *La Maison sans Racine* and *Le Message*. The omniscient narrator is the most contested literary voice in literature. Abandoned in contemporary literature as outdated, it is a "morally suspect" voice that acts like God, that pretends to have a deep knowledge of human nature, and that has a privileged access to all the protagonists' thoughts and actions, irrespective of time and space. Rebeiz argues that the negative traits for which the omniscient voice have been abandoned are sought traits in narratives dealing with war and gender inequalities, where the narrative voice plays the role of moralist, reminding protagonists and readers of our shared human values.
